9.1.	In order to gain the Certificate in Work-based Learning and Research:  An average mark of 40% or above must be gained from the marks listed in 8.1 above.

<b>10.</b>	<b>Consequence of Failure:</b>
10.1.	<p>A candidate who fails to complete a 30 weeks full-time placement in a workplace(s) relevant to their course will be allowed to either:</p> <p>Defer their subsequent studies for a year to complete their 30 weeks full-time in placement</p> <p>OR</p> <p>Complete the required 30 weeks full-time at a later date, for example during holidays or after completing the subsequent year</p> <p>OR</p> <p>Exit the placement year scheme and restart studies at the start of the subsequent year</p>
10.2.	<p>A candidate who fails the placement year summative assessment shall be given the opportunity to resubmit. The candidate will be required to resubmit their Project Report and a new assessment mark will be given.</p> <p>The overall average mark obtained at the second attempt shall be no greater than 40%.</p>
10.3.	<p>If the candidate has not completed their Reflective Oral Presentation, s/he can resit the Reflective Oral Presentation on one further occasion.</p>
10.4.	<p>A candidate who fails after a second attempt will be required to withdraw from the course. S/he has a right of appeal as described in the College Regulations.</p>
